# 1. Context of the Conference and Theme:

The research area of leveraging digital transformation and artificial intelligence for sustaining peace and democracy is highly relevant in today's world. As digital technologies continue to advance rapidly, they have the potential to significantly impact various aspects of society, including governance, the economy, and social interactions. Every citizen is aware that digital technologies have transformed our individual and collective lives. Scholars from peace research and democratic theorists have started to take stock of this transformation and to trace how democratic theory and institutions should respond (Bernholz, Landemore, & Reich, 2021). Artificial intelligence has the potential to revolutionise the way we approach peacebuilding and democratic processes. However, there are also concerns about the potential risks associated with these technologies, such as issues related to privacy, security, and accountability (Thiel, 2022). The United Nations has launched a strategy for the digital transformation of peacekeeping to drive technology innovation and maximise the potential of current and new technologies to help peacekeeping missions carry out their mandates, and ensure the responsible use of digital technologies by peace operations (United Nations, 2022).

Democratic peace theorists argue that digital technologies can enhance democratic processes by increasing citizen participation, promoting transparency, and facilitating the flow of information and they are also concerned about the potential risks associated with these technologies, such as issues related to privacy, security, and the spread of misinformation (<u>Reiter, 2019</u>). There is ongoing research and discussion on this topic, as scholars continue to explore the potential benefits and challenges of these technologies for promoting peace and democracy. It is therefore crucial to carefully consider how we can leverage digital transformation and AI in a responsible and ethical manner to promote peace and democracy.

We welcome submissions on a wide range of topics, including but not limited to:

- Innovations and ways of promoting peace and justice.
- Digital Platforms and AI in promoting transparency and accountability.

- We are going to stick with the one-person-one-presentation rule. This does not include the role as panel chair or discussant.
- The full paper is a must for the paper presentation. The paper should be original and must not be under review/ publication process anywhere else.
- All the submissions having more than 20% plagiarism result through plagiarism tests will be rejected.

- Language of the paper: English

- Margins: 1.5 inch on the left, 1 inch on the top/bottom and right side.
- Line spacing: 1.5

#### Abstract

The abstract should state the main objective(s), problem/ issue, used design/methodology/ approach, main findings, and conclusions of the study. The abstract should contain max. 250

words. (Times New Roman 10pt, block-aligned)

Keywords: *3-5 keywords, in alphabetical order, separated by commas* (Times New Roman 10pt, Italic, Block-aligned)

#### Introduction

This section should focus on the introduction to the topic, and the aim/ objective(s) of the study and the rationale for conducting the study. Do not use subheadings.

#### **Literature Review**

This section should address the related theoretical (if any) and empirical literature leading to arguments.

#### Methodology/Design/Approach

This section should provide enough details on the type of study, sampling, data collection methods, variables, conceptual framework, and hypotheses of the study. For a qualitative type of study, this section can be modified by the author(s). Might not apply to conceptual and literature review papers.

#### **Results and Discussions**

This section may be divided into subsections or may be combined. Can use Tables and Figures where appropriate. Comparing and contradicting the findings with prior studies can be addressed.

#### **Conclusion and contributions**

This section should clearly explain the main conclusions drawn from the findings of the study. Write the contributions as well.

#### Acknowledgments

All acknowledgments (if any) should be included at the very end of the manuscript before the references. Anyone who contributed to the research or manuscript, but who is not a listed author, could be acknowledged (with their permission). It can also include the details of the funding used in the study.

#### **References and bibliography**

## Suggestions for the Presentations at the conference:

- Each presenter will get 10-12 minutes for the presentation.
- Have one main idea per slide.
- Limit yourself to no more than 4-5 major bullets per slide.
- Less is more maximum of 30 words per slide.
- Use font size of at least 22 pt.
- Use sans-serif fonts.
- Check for spelling and grammar.
- Use high contrast colors.
- Graphs are better than tables.
- The suggested structure for the slides is: Title/Cover Slide (1 Slide); Introduction/Background/Context (1-2 Slides); Methodology (1-2 Slides); Results/Findings/Discussions/Arguments (3-4 Slides); Conclusion (1 Slide).
- Aim for maximum 7-8 slides only to become precise and focused on the topic of the presentations.
